The following item was called up for consideration:

Continuation of the Newhall County Water District Annexation No. 2005-30.

Commissioner Yaroslavsky requested clarification on the initial reasoning for the continuance of this item from the February 14, 2007 agenda. John Kratlli, Legal Counsel, reported that as a result of late notification of a pending legal matter related to his item, further investigation of said legal matter was a prudent and precautionary stance for the Commission to take. Mr. Tom Bunn, an attorney representing Newhall County Water District and Mr. Mark Gates addressed the commission.
