NOTICE OF HEARINGS/PROCEEDINGS

**Los Angeles County Sanitation District No. 2
Reconfirmation of the Municipal Service Review (MSR), and
Amendment to the Sphere of Influence (SOI) Boundary**

AND

**Los Angeles County Sanitation District No. 34
Reconfirmation of the Municipal Service Review (MSR), and
Adoption of a Coterminous Sphere of Influence (SOI) Boundary**

Pursuant to Government Code Section 56650 *et seq.*, the Local Agency Formation Commission for the County of Los Angeles ("LAFCO" or "Commission") hereby gives notice as follows:

1. LAFCO will hold public hearings/proceedings on Wednesday, January 13, 2016, at 9:00 a.m., to hear and receive any oral or written objections, or evidence that is made, presented, or filed regarding the proposed Reconfirmation of the MSR, and Amendment to the SOI Boundary, for the Los Angeles County Sanitation District No. 2; and Reconfirmation of the MSR, and Adoption of a Coterminous SOI Boundary, for the Los Angeles County Sanitation District No. 34 ("Proposals"). The hearings/proceedings will be held in the Board of Supervisors Hearing Room, Room 381B, Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012, or at such date and time as it may be continued by LAFCO.

2. These Hearings/Proceedings include a Commission-initiated Reconfirmation of the MSR, and Amendment to the SOI Boundary, for the Los Angeles County Sanitation District No. 2 (District No. 2); and Reconfirmation of the MSR, and Adoption of a Coterminous SOI Boundary, for the Los Angeles County Sanitation District No. 34 (District No. 34).

3. The Proposals have been assigned the following short form designations:

Reconfirmation of the MSR, and Amendment to the SOI Boundary, for District No. 2

AND

Reconfirmation of the MSR, and Adoption of a Coterminous SOI Boundary, for District No. 34

4. The Proposals include the Reconfirmation of the Los Angeles County Sanitation Districts Nos. 2 and 34 MSRs, pursuant to the Los Angeles County Sanitation Districts MSR originally adopted by the Commission on May 25, 2005.
5. The affected territory for the Proposals is all territory within District No. 2 and District No. 34.
6. The reason for the Proposals is that State Law requires that LAFCO periodically prepare MSRs for public agencies within its jurisdiction (Government Code Section 56430) and designate an SOI for each public agency (Government Code Section 56425).
7. Said hearings/proceedings on the proposal for Reconfirmation of the MSR, and Amendment to the SOI Boundary, for District No. 2; and the Reconfirmation of the MSR, and Adoption of a Coterminous SOI Boundary, for District No. 34 will be held at 9:00 a.m., on the 13th day of January 2016, in Room 381B of the Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, California, 90012, or as it may be continued. At said hearings/proceedings, any interested person may present testimony or submit written opposition or comments prior to the conclusion of the Commission hearings/proceedings on the proposals. In the event that any written opposition or comments are mailed or hand-delivered to LAFCO, rather than being hand-delivered to the hearing location listed herein before the conclusion of the Commission hearings/proceedings on these proposals, such mailed or hand-delivered written opposition or comments must be received by the LAFCO Office, at the different address given below, no later than 5:00 p.m. on the business day preceding the date set for hearings/proceedings in order for the mailed or hand-delivered opposition or comments to be deemed timely and to be considered by the Commission in connection with the noticed hearings/proceedings.

8. The subject proposals and all related documents are on file in the office of the Local Agency Formation Commission, 80 South Lake Avenue, Suite 870, Pasadena, California 91101, and may be examined by any person upon request.
