A speaker from the audience approached the Commission with concerns regarding Consent Item D – County Sanitation District No. 22 - Annexation 394. As a result, Consent Item D was held from consideration to allow staff the opportunity to address the speaker's concerns.

East Los Angeles Incorporation Report:

The Deputy Executive Office reported that on September 8, 2009, the East Los Angeles Resident's Association (ELARA) filed a letter requesting a 59 day extension, to November 20, 2009, to submit funding for the CFA.

Commissioner Molina asked if it was permissible for LAFCO to advance ELARA the necessary funding for the CFA, pending a decision by the Legislature on AB 711 (Calderon), which would appropriate \$112,000 to LAFCO to loan to ELARA. Legal Counsel responded that LAFCO could, at its discretion, advance the funds to ELARA, if it has the budgetary resources. Legal Counsel further noted that a decision to advance funds would be a policy decision.

Commissioner Molina further recommended that staff contact the consultant, Economic & Planning Systems Inc. to determine if the firm would be agreeable to extending the CFA contract pricing an additional 59 days to November 20, 2009.

Benjamin Cardenas, President of the East Los Angeles Resident Association, spoke in support of the 59-day extension.

After discussion, the Commission agreed that should staff be unable to obtain a pricing extension from the consultant the Chairman would call a special meeting of the Commission to explore its options.
