The following item was called up for consideration:

Consideration of terminating CALAFCO membership and forming a Southern California LAFCO organization.

After considerable discussion, and on motion of Commissioner Dear, seconded by Commissioner Herrera, unanimously carried (Commissioner DiGiuseppe being absent), the Commission ordered that unless the CALAFCO Board, at its January 15, 2010 meeting, approves regional representation, the Chair and Executive Officer are authorized to implement the following recommended actions:

- 1. Join efforts to form a new Southern California LAFCO organization;
- 2. Continue to pursue efforts to become part of a southern California Legislative Committee;
- 3. Advise legislative members that CALAFCO does not represent the Los Angeles LAFCO:
- 4. Send written notification to CALAFCO of Los Angeles LAFCO's intent to resign its membership, effective July 1, 2010; and
- 5. Until CALAFCO general membership approves regional representation, cease paying membership dues to CALAFCO.

Merit Increase - Deputy Executive Officer.

After discussion, and on motion of Commissioner Dear, seconded by Commissioner Herrera, unanimously carried (Commissioner DiGiuseppe being absent; and Commissioners Finlay and Molina voting no), the Commission approved a 7.5% merit increase for the Deputy Executive Officer.
