East Los Angeles Incorporation Status Report - Award of contract for preparation of an environmental review.

On motion of Commissioner Spence, seconded by Commissioner Finlay, unanimously carried (Commissioner Gladbach being absent), the commission awarded the contract to BonTerra Consulting for preparation of an Initial study and CEQA documents for the proposed Incorporation of East Los Angeles proposal, at the following not to exceed rates: \$23,325 for a Negative Declaration; 24,975 for a Mitigated Negative Declaration; and if necessary \$99,544 for an Environmental Impact Report; and further authorized the Deputy Executive Officer to execute the contract.

Robert Bishop, an owner of property within the boundaries of Annexation 339 to County Sanitation District No. 14 submitted a request to address the Commission regarding the potential for an increase in property taxes as a result to the annexation.

Commissioner Dear made a motion, seconded by Commissioner Finlay, to reconsider the Protest Hearing on Los Angeles County Sanitation District No. 14 - Annexation No. 339, to allow for public comment. Said motion was unanimously carried.

David Bruns and Donna Kitt, representing the Los Angeles County Sanitation Districts responded to Mr. Bishop's questions.

After discussion, and on motion of Commissioner Yaroslavsky, seconded by Commissioner Finlay, unanimously carried (Commissioner Gladbach being absent), the commission reaffirmed its approval of Protest Hearing on Los Angeles County Sanitation District No. 14 - Annexation No. 339.
