- The meeting was called to order at 9:00 a.m., in Room 381-B of the County Hall of Administration.
- 2 The Pledge of Allegiance was led by Commissioner Jerry Gladbach.

The committee narrowed the field and recommended that the Commission interview 6 finalists.

The E.O. thanked Commissioner Donald Dear, who chaired the Alternate Public Member Committee, and Commissioners Margaret Finlay, Henri Pellissier, and Zev Yaroslavsky, all of whom served on the Committee.

The E.O. stated that all six finalists were present and ready to be interviewed, and that the interviews would be conducted in open session.

Chairman Gladbach selected from an envelope with the finalists' names inside, and a random order of interviews was determined: 1) Gerard McCallum; 2) Harry Leon; 3) Harold james Bissner III; 4) Adriana Martinez; 5) Joan Yacovone; and 6) Ron Tepper.

All finalists stepped out into a conference room to wait to be interviewed.
