
## NOTICE OF PUBLIC HEARING/PROCEEDINGS

## Establishment No. 2018-05 of the Sphere of Influence for the Wrightwood Community Service District (Los Angeles County Portion)

Pursuant to Government Code Section 56650 *et seq.,* the Local Agency Formation Commission for the County of Los Angeles ("LAFCO" or "Commission") hereby gives notice as follows:

- LAFCO will hold a public hearing/proceedings on Wednesday, August 8<sup>th</sup>, 2018 at 9:00 a.m., to hear and receive any oral or written objections, or evidence that is made, presented, or filed regarding the proposed <u>establishment of the Sphere of Influence for the Wrightwood Community Services District.</u>
   The hearing will be held in the Board of Supervisors Hearing Room, Room 381B, Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012, or to such date and time as it may be continued by LAFCO.
- The Proposal has been assigned the following short form designation:
   "Establishment No. 2018-05 of the Sphere of Influence for the Wrightwood Community Services District (Los Angeles County Portion)".
- 3. The affected territory is generally located southwest of the intersection of Angeles Crest Highway and Big Pines Highway, in the unincorporated community known as Wrightwood.
- 4. Pursuant to Government Code Section 56426.5(b), the Commission shall determine the Sphere of Influence (SOI) for any newly formed district within one year of the effective date of formation.
  - . Said hearing/proceedings on the proposal for establishment of a Sphere of Influence will be held at 9:00 a.m., on the 8th day of August 2018, in Room 381B of the Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, California, 90012, or as it may be continued. At said hearing/proceedings, any interested person may present testimony or submit written opposition or comments prior to the conclusion of the Commission hearing/proceedings on the proposal. In the event that any written opposition or comments are mailed or hand-delivered to LAFCO, rather than being hand-delivered to the hearing location listed herein before the conclusion of the Commission hearing/proceedings on this proposal, such mailed or hand-delivered written opposition or comments must be received by the LAFCO Office, at the different address given below, no later than 5:00 p.m. on the business day preceding the date set for hearing/proceedings in order for the mailed or hand-delivered opposition or comments to be deemed timely and to be considered by the Commission in connection with the noticed hearing/proceedings.
- 6. The subject proposal and all related documents are on file in the office of the Local Agency Formation Commission, 80 South Lake Avenue, Suite 870, Pasadena, California 91101, and may be examined by any person upon request. LAFCO meeting agendas are posted on-line prior to the meetings at www.lalafco.org. For further information, contact the LAFCO office at (626) 204-6500. The office hours are Monday Thursday, 8:00 a.m. to 5:00 p.m., closed Fridays and Holidays.

Depending on the application involved, State Law requires that LAFCO notify various parties, such as landowners and registered voters, both within and adjacent to the affected territory. For this reason, you may receive multiple copies of this notice.
