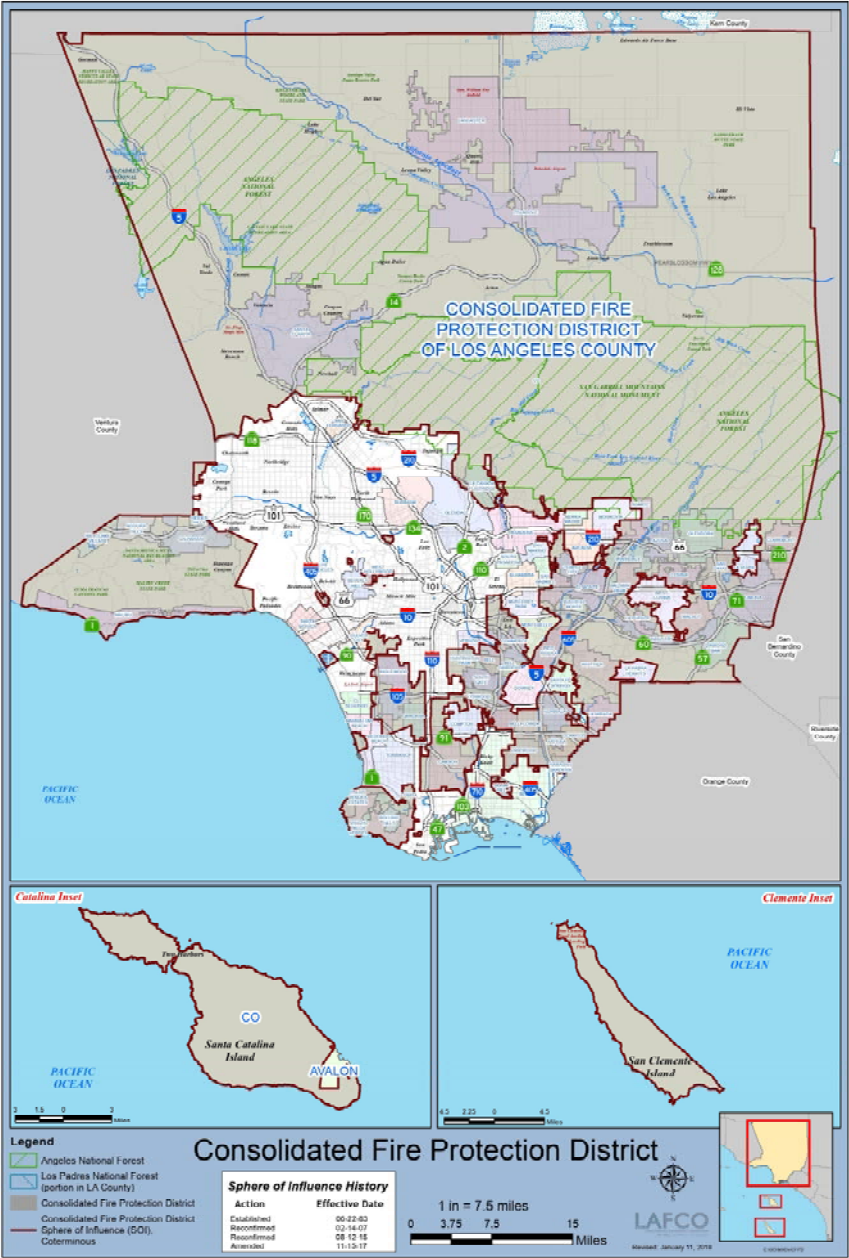

LAFCO will hold a hearing/proceedings on Wednesday, July 8, 2020 at 9:00 a.m., to hear and receive any oral or written protest, objections, or evidence that is made, presented, or filed regarding the proposed Municipal Service Review (MSR) and Sphere of Influence (SOI) Update of inhabited territory to the Consolidated Fire Protection District of Los Angeles County ("Proposal"). The hearing was previously noticed for hearing in the Board of Supervisors Hearing Room, Room 381B, Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012, or to such date and time as it may be continued by LAFCO. Given the ongoing public health emergency, the meeting will proceed as a virtual meeting with public participation by U.S. mail, internet and/or telephone as described herein.
2. The Hearing/Proceedings include potential action on a Commission initiated MSR and SOI Update.
3. The Proposal has been assigned the following short form designation:  
"MSR No. 2020-02—Municipal Service Review and Sphere of Influence Update for the Consolidated Fire Protection District of Los Angeles County".
4. The Proposal includes the proposed adoption of an MSR and Update to the SOI for the Consolidated Fire Protection District of Los Angeles County.

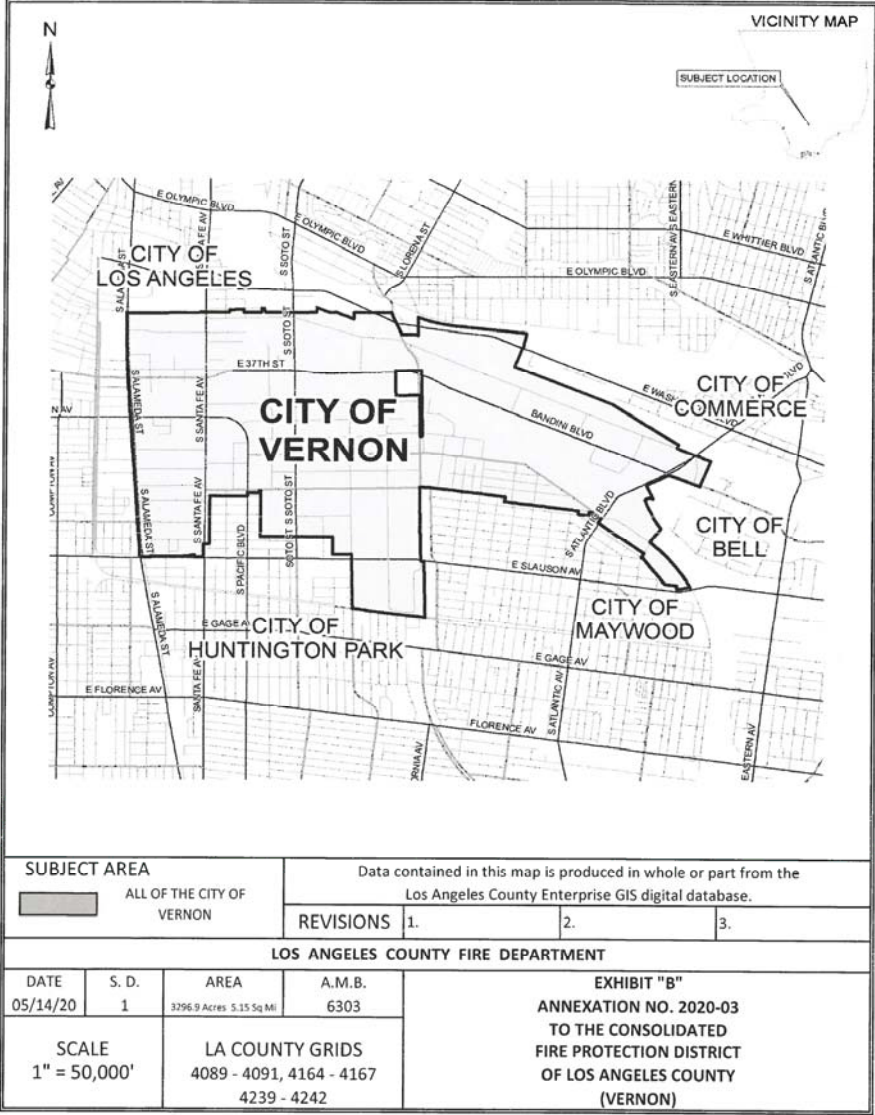
