#### ANNEXATION NO. 32 TO THE COUNTY SANITATION DISTRICT NO. 16 OF LOS ANGELES COUNTY

Pursuant to Government Code Section 56150 *et seq.,* the Local Agency Formation Commission for the County of Los Angeles ("LAFCO" or "Commission") hereby gives notice as follows:

LAFCO will hold a public hearing/proceedings on Wednesday, June 10, 2020 at 9:00 a.m., to hear and receive any written protest, objections, or evidence that is made, presented, or filed regarding the proposed annexation of uninhabited territory to the County Sanitation District No. 16 of Los Angeles County ("Proposal"). The hearing will be conducted as a virtual meeting with telephone (1-877-873-8017) and web access (<a href="http://bos.lacounty.gov/Board-Meeting/Live-Broadcast">http://bos.lacounty.gov/Board-Meeting/Live-Broadcast</a>), pursuant to the provisions of the Governor's Executive Orders N-25-20 and N-29-20, under the modified laws of the Ralph M. Brown Act for the COVID-19 emergency, as well as the County of Los Angeles "Safer at Home Order for Control of COVID-19". Members of the Commission will attend the meeting via teleconference and participate in the meeting to the same extent as if they were present. There will be no physical access to virtual meetings. Any public comments submitted as described below, will be read during the meeting, at a maximum of three minutes per comment, per item.






