

- 4. The Proposal includes annexation of 349± acres within a residential area into the boundary of the Santa Clarita Valley Water Agency. The affected territory includes approximately 545 single-family homes, three schools, six landscaped areas, two landscaped district areas, and 21 vacant parcels.

The affected territory is generally located southwest of the intersection of Old Rock Road and Valencia Boulevard, in Los Angeles County unincorporated territory of Stevenson Ranch, near the City of Santa Clarita. See map on reverse for a graphic depiction of the exterior boundaries relative to the existing boundaries of the Santa Clarita Valley Water Agency (SCVWA).




