The EO indicated that LAFCO has not adjusted fees since 2006, and that existing fees do not cover the costs for staff to process, review, and analyze proposals. The EO noted that increasing fees is intended to recover costs and to include incremental fee increases (adjust for inflation) in accordance with the Consumer Price Index. He also noted that the proposed fees are consistent with fixed fees charged by other LAFCOs.

- Directed staff to adjust fees annually by the amount of the increase in the Consumer Price Index (for Urban Wage Earners and Clerical Workers published by the U.S. Bureau of Labor Statistics for the Los Angeles-Long Beach-Anaheim Area) (CPI Index), to amend the fee schedule accordingly each year on July 1<sup>st</sup>; and to provide advance notification to representatives of the County of Los Angeles and the cities and independent special districts in Los Angeles County; and
- Directed staff to conduct a thorough review and analysis of the existing calculations of tasks, hours expended, and burdened labor rates, to identify the then-current costs beyond the increases tied to the CPI Index, and make a recommendation to the Commission if any changes to the filing fee schedule are warranted, every five years, beginning in July-

## RESOLUTION NO. 2023-01RMD RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION FOR THE COUNTY OF LOS ANGELES MAKING DETERMINATIONS ADOPTING A FILING FEE SCHEDULE

WHEREAS, the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (commencing with Government Code § 56000) authorizes the Local Agency Formation Commission for the County of Los Angeles (Commission or LAFCO) to establish a schedule of fees and a schedule of service charges, pursuant to Government Code § 56383;

WHEREAS, LAFCO enacted a filing fee schedule in January, 2006; and
WHEREAS, applicants who submit a proposal to LAFCO pay filing fees consistent with
the schedule of fees implemented in 2006; and

WHEREAS, the current filing fees do not cover the costs for LAFCO staff to process, review, and analyze each proposal, as documented in the February 8<sup>th</sup> staff report and attachments associated with this resolution making determinations, and as further documented in the January 11<sup>th</sup> staff report and attachments presented to and considered by the Commission; and

WHEREAS, the Commission considered a written staff report and an oral presentation by staff at the January 11, 2023 Meeting, and directed staff to provide notice for a public hearing;

WHEREAS, staff provided a copy of the proposed filing fee schedule to representatives of the County of Los Angeles, the eighty-eight (88) cities in Los Angeles County, and the fifty-three (53) independent special districts in Los Angeles County, immediately after the Commission's January 11<sup>th</sup> Meeting; and

WHEREAS, staff compiled comments from public agency representatives, provided copies to the Commission, and the Commission has considered those comments; and

WHEREAS, the Commission set the public hearing for February 8, 2023 at 9:00 a.m., at the Los Angeles County Board of Supervisors Hearing Room, Kenneth Hahn Hall of Administration Room 381-B, located at 500 West Temple Street, Los Angeles, California, 90012;

WHEREAS, the Executive Officer has given notice of the public hearing pursuant to Government Code §§ 56153, 56154, 56383, and 66016, wherein the public hearing notice was published in a newspaper of general circulation in the County of Los Angeles on Tuesday, January 17, 2023, which is at least 21 days prior to the February 8<sup>th</sup> public hearing; and

WHEREAS, the February 8, 2023 Commission Meeting was canceled, and this agenda item was rescheduled for the March 8, 2023 Commission Meeting;

WHEREAS, at the time and place fixed in the notice, and as continued to March 8, 2023, the hearing was held, and any and all oral or written comments, objections, objections, and evidence were received and considered; and

WHEREAS, staff has prepared a time and materials study documenting the cost to LAFCO to process, review, and analyze a proposal, a copy of which is attached to the staff report associated with this resolution making determinations;

WHEREAS, the time and materials study demonstrates that the proposed filing fees are at amounts which do not exceed the estimated amount required to provide the service for which the fee or service charge is levied, as required by Government Code § 66016; and

WHEREAS, staff posted the time and materials study to the Commission website on January 23, 2023, in compliance with Government Code § 66016; and

WHEREAS, staff has prepared a chart which compares the existing fees that are currently being charged pursuant to the filing fee schedule implemented in 2006, as well as the proposed filing fee schedule, a copy of which is attached to the staff report associated with this resolution making determinations;

WHEREAS, and in the interest of affording potential applicants adequate time in which to file a proposal (or proposals) with LAFCO in advance of the new filing fees being enacted, this filing fee schedule will take effect on July 1, 2023; and

WHEREAS, and to account for annual increased costs for LAFCO staff to process, review, and analyze proposals (applications), the Commission hereby authorizes staff to adjust fees annually, on July 1<sup>st</sup> of each year, in an amount (percentage) equal to the amount of the increase in the Consumer Price Index (for Urban Wage Earners and Clerical Workers published by the U.S. Bureau of Labor Statistics for the Los Angeles-Long Beach-Anaheim Area), with further direction that staff provide notice, in advance of the annual adjustment, to representatives of the County, the cities and special districts in Los Angeles County, of the revised fees, and that staff update the filing fee schedule on the LAFCO website accordingly;

WHEREAS, Georgia Eliopulos ("landowner" or "Applicant") submitted a petition for proceedings, to the Local Agency Formation Commission for the County of Los Angeles (Commission), pursuant to, Division 3, Title 5, of the California Government Code (commencing with § 56000, the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000), for annexation of territory herein described to the Los Angeles County Waterworks District No. 40, Antelope Valley (District), all within the City of Palmdale (City); and

WHEREAS, the proposed annexation consists of approximately 6.58± acres of uninhabited territory and is assigned the following distinctive short-form designation:

"Annexation No. 2021-02 to the Los Angeles County Waterworks District No. 40, Antelope Valley"; and

WHEREAS, a description of the boundaries and map of the proposal are set forth in Exhibits "A" and "B", attached hereto and by this reference incorporated herein; and

WHEREAS, the principal reason for the proposed annexation is for the District to provide water service; and

WHEREAS, the Executive Officer has reviewed the proposal and submitted to the Commission a written report, including his recommendations therein; and

WHEREAS, the Executive Officer has given notice of the public hearing pursuant to Government Code §§ 56150-56160, 57025, and 57026, wherein the public hearing notice was

published in a newspaper of general circulation in the County of Los Angeles on February 8, 2023, which is at least 21 days prior to the public hearing, and said hearing notice was also mailed to all required recipients by first-class mail on or before the date of newspaper publication; and

WHEREAS, in accordance with Government Code § 56663, mailed notice pursuant to Government Code § 56157 has been given to landowners and registered voters within the affected territory; and the mailed notice discloses that: 1) the potential for the extension or continuation of any previously authorized charge, fee, assessment, or tax by the City and/or District in the affected territory, and 2) unless written opposition to the proposal is received before the conclusion of the Commission proceeding on the proposal, the Commission intends to waive protest proceedings; and

WHEREAS, on March 8, 2023, after being duly and properly noticed, this proposal came on for hearing, at which time this Commission heard and received all oral and written testimony, objections, and evidence which were made, presented or filed, and all persons present were given an opportunity to hear and be heard with respect to this proposal and the report of the Executive Officer; and

WHEREAS, the Commission, acting as the conducting authority, has the ministerial duty of accepting any written opposition to the proposal and either, waive protest proceedings entirely, pursuant to Government Code § 56663, if no written opposition was received.

NOW, THEREFORE, BE IT RESOLVED as follows:

 Acting in its role as a responsible agency with respect to Annexation No. 2021-02 to the Angeles County Waterworks District No. 40, Antelope Valley, pursuant to State CEQA Guidelines § 15096, the Commission considers the Mitigated Negative Declaration prepared and adopted by the City of Palmdale, as lead agency, on July 9, 2015, together with any comments received during the public review process; certifies that the Commission has independently reviewed and considered and reached its own conclusions regarding the environmental effects of the project as shown in the Mitigated Negative Declaration; and adopts the Mitigation Monitoring Program and Compliance Record for the project, finding that the Mitigation Monitoring Program and Compliance Record is adequately designed to ensure compliance with the mitigation measures during project implementation as applicable to the responsible agency.

- 2. The Commission finds the number of written opposition filed by landowners and registered voters is <u>0</u>.
- Mailed notice has been provided pursuant to Government Code § 56663 on February 8,
   2023.
- 4. A description of the boundaries and map of the proposal, as approved by this Commission, are set forth in Exhibits "A" and "B", attached hereto and by this reference incorporated herein.
- 5. The affected territory consists of 6.58± acres, is uninhabited, and is assigned the following short form designation: "Annexation No. 2021-02 to the Los Angeles County Waterworks District No. 40, Antelope Valley".
- 6. Annexation No. 2021-02 to the Los Angeles County Waterworks District No. 40, Antelope Valley is hereby approved, subject to the following terms and conditions:
  - a. The landowner agrees to defend, hold harmless and indemnify LAFCO and/or its

- agents, officers and employees from any claim, action or proceeding against LAFCO and/or its agents, officers and employees to attack, set aside, void or annul the approval of LAFCO concerning this proposal or any action relating to or arising out of such approval.
- The effective date of the annexation shall be the date of recordation of the
   Certificate of Completion with the Los Angeles County Registrar Recorder/County Clerk.
- Recordation of the Certificate of Completion shall not occur prior to the
   conclusion of the 30-day reconsideration period proved under Government Code
   § 56895.
- d. All fees due to LAFCO, the County of Los Angeles (including, but not limited to, fees owed to the County Assessor and/or the Registrar-Recorder/County Clerk), and the State of California Board of Equalization; shall be paid by the Applicant, in full, prior to LAFCO's filing the Certificate of Completion. Failure to pay any and all fees due to LAFCO, the County of Los Angeles, and the State Board of Equalization, within one year of the Commission approval of this change of organization/reorganization, will result in the change of organization/reorganization being terminated pursuant to Government Code §57001 unless, prior to expiration of that year, the Commission authorizes an extension of time for that completion.
- e. The territory so annexed shall be subject to the payment of such service charges, assessments or taxes as may be legally imposed by the District.

- f. The regular County assessment roll shall be utilized by the District.
- g. The affected territory will be taxed for any existing general indebtedness, if any, of the District.
- h. Annexation of the affected territory described in Exhibits "A" and "B" to the District.
- i. The map and geographic description of the affected territory shall comply with all requirements of LAFCO, the Los Angeles County Registrar-Recorder/County Clerk, and the State of California Board of Equalization. If LAFCO, the Los Angeles County Registrar-Recorder/County Clerk, and/or the State of California Board of Equalization require changes, the map and geographic description shall be revised and all associated costs shall be the responsibility of the applicant.
- j. Except to the extent in conflict with "a" through "i", above, the general terms and conditions contained in Chapter 2 of Part 5, Division 3, Title 5 of the California Government Code (commencing with Government Code § 57325) shall apply to this annexation.
- 7. Pursuant to Government Code § 56663, the Commission finds that all the following have occurred: 1) mailed notice pursuant to Government Code § 56157 has been given to landowners and registered voters within the affected territory; 2) the mailed notice discloses the potential for the extension or continuation of any previously authorized charge, fee, assessment, or tax by the City and/or District in the affected territory; 3) the mailed notice discloses that unless written opposition to the proposal is received before the conclusion of the Commission proceeding on the proposal, the Commission intends

- to waive protest proceedings; and 4) no written opposition to the proposal from landowners or registered voters have been submitted before the conclusion of the proceeding/hearing. Therefore, pursuant to Government Code § 56663, the Commission hereby waives protest proceedings.
- 8. The Commission hereby orders the uninhabited territory described in Exhibits "A" and "B" annexed to the Los Angeles County Waterworks District No. 40, Antelope Valley.
- 9. The Executive Officer is hereby authorized and directed to mail copies of this resolution as provided in Government Code § 56882.
- 10. The Executive Officer is directed to transmit a copy of this resolution to the District, upon the Applicant's payment of the applicable fees required by Government Code § 54902.5 and prepare, execute and file a certificate of completion with the appropriate public agencies, pursuant to Government Code § 57200, et seq.
- 11. Pursuant to Government Code § 56883, the Executive Officer may make non-substantive corrections to this resolution to address any technical defect, error, irregularity, or omission.
