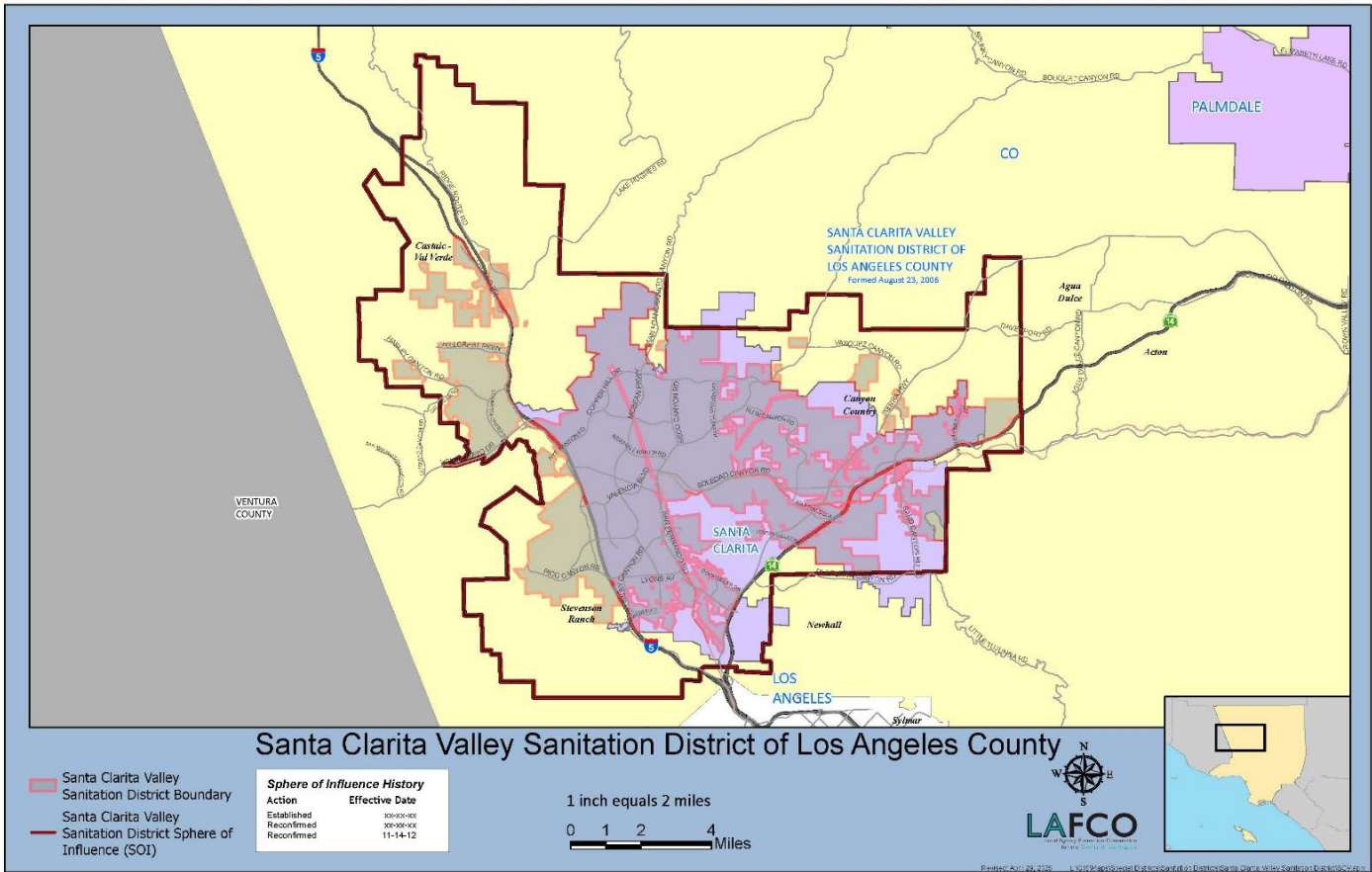
**EXERCISE OF NEW OR DIFFERENT FUNCTIONS OR CLASSES OF SERVICES NO. 2026-08 FOR
THE SANTA CLARITA VALLEY SANITATION DISTRICT OF LOS ANGELES COUNTY**

This proposal was originally noticed for the September 9, 2026 public hearing. Pursuant to Government Code Sections 56150 et seq., the Local Agency Formation Commission for the County of Los Angeles ("LAFCO" or "Commission") hereby gives notice as follows:

1. LAFCO will hold a public hearing/proceedings on Wednesday, October 14, 2026 at 9:00 a.m., to hear and receive any oral or written objections, or evidence that is made, presented, or filed regarding the request to Exercise New or Different Functions or Classes of Services for the Santa Clarita Valley Sanitation District of Los Angeles County (referred to as "proposal"). The hearing will be held in Room 381B, Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012, unless cancelled or rescheduled by the Commission or the Commission chair approves an alternate meeting location.
2. Proceedings to Exercise New or Different Functions or Classes of Services for the Santa Clarita Valley Sanitation District were initiated by resolution of application by the Santa Clarita Valley Sanitation District of Los Angeles County identified herein. The request for the Proposal, in the ordinary course, would require the conduct of protest proceedings; however, **the Commission hereby gives notice pursuant to Government Code Section 56157 that, unless written opposition to the Proposal is received from landowners and/or registered voters within the affected territory before the conclusion of the aforementioned Commission hearing/proceedings on the Proposal, the Commission intends to waive protest proceedings, as authorized by, and in compliance with, California Government Code Section 56663.**
3. The Proposal has been assigned the following short form designations:
"Exercise of New or Different Functions or Classes of Services" for the following:

Exercise of New or Different Functions or Classes of Services No. 2026-08 for the Santa Clarita Valley Sanitation District of Los Angeles County.
4. The Proposal is to Exercise New or Different Functions or Classes of Services for the Santa Clarita Valley Sanitation District of Los Angeles County.
5. The reason for the Proposal is to provide stormwater and dry-weather urban runoff services within the District boundaries.
6. The affected territory includes portions of the City of Santa Clarita and surrounding unincorporated areas, encompassing the boundaries of the Santa Clarita Valley Sanitation District in its entirety. The area can be generally described as south of the Castaic Lake Recreation Area, east of the Los Angeles/Ventura County Boundary line (including portions of the unincorporated areas of Castaic and Val Verde, and Stevenson Ranch), north of the City of Los Angeles, and west of Agua Dulce and Acton. The size of the affected territory is approximately 67 acres. Refer to accompanying map for a description of the affected territory for the proposal.
7. Said hearing/proceedings on the proposal will be held at 9:00 a.m., on the 14th day of October 2026, in Room 381B of the Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, California, 90012, unless cancelled or rescheduled by the Commission or the Commission chair approves an alternate meeting location. At said hearing/proceedings, any interested person may present testimony or submit written opposition or comments prior to the conclusion of the Commission hearing/proceedings on the Proposal. In the event that any written opposition or comments are e-mailed to info@lalafco.org, mailed or hand-delivered to LAFCO, rather than being hand-delivered to the hearing location listed herein before the conclusion of the Commission hearing/proceedings on this Proposal, such mailed or hand-delivered written opposition or comments must be received by the LAFCO Office, at the different address given below, no later than 5:00 p.m. on the business day preceding the date set for hearing/proceedings in order for the mailed or hand-delivered opposition or comments to be deemed timely and to be considered by the Commission in connection with the noticed hearing/proceedings.
8. The subject proposal and all related documents are on file in the office of the Local Agency Formation Commission, 80 South Lake Avenue, Suite 870, Pasadena, California 91101, and may be examined by any person upon request. LAFCO meeting agendas are posted on-line prior to the meetings at www.lalafco.org. For further information, contact the LAFCO office at (626) 204-6500. The office hours are Monday – Thursday, 8:00 a.m. to 5:00 p.m., closed Fridays and Holidays.

Depending on the application involved, State Law requires that LAFCO notify various parties, such as landowners and registered voters, both within and adjacent to the affected territory. For this reason, you may receive multiple copies of this notice.

Pursuant to Government Code Section 56150 *et seq.*, the Local Agency Formation Commission for the County of Los Angeles ("LAFCO" or "Commission") hereby gives notice as follows:

1. LAFCO will hold a hearing/proceedings on Wednesday, October 14, 2026 at 9:00 a.m., to hear and receive any oral or written protest, objections, or evidence that is made, presented, or filed regarding the proposed Municipal Service Reviews (MSRs) and Spheres of Influence (SOI) Updates for the Cities of Pasadena and San Marino ("Proposal"). The hearing will be held in the Board of Supervisors Hearing Room, Room 381B, Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, CA 90012, unless cancelled or rescheduled by the Commission or the Commission Chair approves an alternative meeting location.
2. The Hearing/Proceedings include potential action on a Commission initiated MSR and SOI Update.
3. The Proposal includes the proposed MSRs and SOIs for the following cities: Pasadena and San Marino.
4. The affected territory is located within the County of Los Angeles. Maps are available on LAFCO's website at www.lalafco.org under the Meetings and Notice Sections.
5. The reason for the Proposal is that state law requires that LAFCO periodically prepare MSRs for public agencies within LAFCO's jurisdiction (Government Code Section 56430 *et seq.*) and designate and periodically update an SOI for each public agency (Government Code Section 56425 *et seq.*).

Said hearing/proceedings on the Proposal for the Municipal Service Reviews (MSRs) and Sphere of Influence (SOI) Updates for the Cities of Pasadena and San Marino will be held at 9:00 a.m., on the 14th day of October 2026, in Room 381B of the Kenneth Hahn Hall of Administration, 500 West Temple Street, Los Angeles, California, 90012, or as it may be continued.
